## 4. DISCUSSION: KLFR&EMS Proposed District Budget FY 2017-2018

Sue Heim addressed the Board.

Jennifer Johnson presented the Proposed Budget. The tentative millage is 1.000 mill, which is 20.89% above the roll-back rate from the previous year's roll-back rate of.8272 mills. The committed fund balance includes the Trauma District funds of \$316,535 as of October 1, 2017. The unassigned projected fund balance as of September 30, 2018 is \$786,119. The committed Trauma District fund balance as of September 30, 2018 is projected at \$243,035 after expending approximately \$50,000 for KLVFD extrication equipment and \$24,000 for KLVAC for EMS reporting equipment; and the projected committed Vehicle Replacement fund balance as of September 30, 2018 is \$95,278.

There were no changes to the Proposed FY 2017-2018 Budget. During FY18 Legal and Finance will review the insurances for hurricane deductibles, and other possible policy changes.

The projected taxable value for the KLFR&EMS District is \$3,071,952,142.
