6.A. DISCUSSION: Fire Hydrant Project

Commissioner Thomas reported the Phase 5 Fire Hydrant 16-16 has not yet been installed, and Phase 6 needs additional fire hydrant locations.

6.B. DISCUSSION/ACTION: Workmen's Comp

Theron Simmons reported the agent from Richard Insurance, has a policy about the same as the current policy, and he has offered to attend the July 24, 2017 District Meeting. The policy it is a very competitive rate. The insurance will be through the departments versus the district, and it would include divers. Divers have always been covered by the insurance. The Workmen's Compensation Policy will be renewed in October.

7. NEW BUSINESS

7.A. <u>MOTION/APPROVAL</u>: Resolution 2017-004 Motion to Adopt Proposed Millage and Establish the Dates/times for the 1st and Final Public Hearings

The Clerk read Resolution 2017-004 into the record. Jennifer Johnson presented the Resolution. It proposes a 1.0000 mil tax rate, which is \$1.00 per \$1,000.00 of assessed property value. The proposed millage is 20.96% greater than the current rolled-back rate of .8267 mil. The 1st Public Hearing is scheduled for September 18, 2017 at 6:00 p.m. and the Final Public Hearing is scheduled for September 25, 2017 at 6:00 p.m. at Station #24.

<u>MOTION:</u> Commissioner Cullen made a motion to approve Resolution #2017-004 to the Adopt Proposed Millage Rate of 1.0000 mil and Establish the Public Hearings: September 18, 2017 (1st Public Hearing) and September 25, 2017 (Final Pubic Hearing) to be held at Station 24 at 6:00 p.m. Commissioner Thomas seconded the motion.

The vote was as follows: Cullen (Y), Mirabella (Y), Powers (Y), Thomas (Y) and Allen (Y). The motion was passed unanimously.

8. FINANCIAL REPORT

Jennifer did not have any other items to report to the Board.

9. LEGAL COUNSEL REPORT

There were no other items reported by Theron Simmons.

10. AMBULANCE CORPS REPORT

There were no additional items reported to the Board.

11. FIRE DEPARTMENT REPORT

Commissioner Thomas wanted to ensure the firefighters have the training they need to use the equipment the District has purchased for the department. He requested information if additional training needs to be budgeted. Discussion was held, and it was suggested the department not participate in advanced technical training for confined spaces and hazardous materials because these types of emergency incidents require a highly-trained team of firefighters to handle these types of emergency incidents.
